Course Overview

This course is an introductory course primarily targeted towards first and second year undergraduate students. Many of the students enrolled in this course have an interest in some sort of health profession (most likely medical school) and a good portion will have some exposure to their career choice either via family or volunteer experience. The broad intention of this course is to introduce students to the multitude of professions that are currently involved in delivery care in our current healthcare system as well as the environment where all this occurs. I encourage students to put aside their biases for a particular profession and envision alternative career choices. While the actual demands of the course will be minimal compared to the majority of your other courses, like everything in life, the most successful students will invest initiative and self-study to advance their education. Most of the course will be delivered in a seminar format, meaning multiple guest lectures discussing their specific career experiences. There will be several self-study and self-reflection opportunities and discussion among your peers. Finally, you will have the opportunity to present research findings to the class.

A general comment. I realize that this is a large class and I will be lucky to remember a handful of your names. But, COMMUNICATION WITH YOUR INSTRUCTOR FOR THIS CLASS AND ANY OTHER CLASS WILL GO A LONG WAY TO SECURING YOUR SUCCESS! I cannot address and/or help with a problem unless I am aware of the issue, and trust me, you will get less skeptical looks from your instructor if you communicate BEFORE not AFTER the fact.

Academic Requirements & Grading

Attendance

Since a majority of the course is delivered in seminar format, attendance is a critical requirement.

A couple comments on attendance:

- Attending a class means that you are in the class prior to the time that the class is scheduled to begin. It is understandable that coming from the main campus area you may occasionally be delayed and unable to get to the HPNP building prior to class beginning (In general 15 minutes is adequate time to walk from Matherly Hall to HPNP auditorium). If you are going to be late, please use discretion while entering the class and finding your seat. If you are going to be more than 15 minutes late (that would be 30 minutes from end of previous class), you will not get credit for class attendance, unless otherwise arranged beforehand with instructor.
- Attendance is not just a physical presence, but being an active listener. In other words, the use of laptops, tablets and smartphones to while away your time on social media sites is STRONGLY discouraged. Also, sitting in a chair with head down and/or feet up is disrespectful to any speakers. The instructor will enforce this, excessive or blatant violations of this guideline will result in forfeiture of attendance credit for that day!

Attendance will be taken at every class meeting. Attendance will be taken via sign-in sheets placed out at the end of class.

Discussion Boards

The intention of the message boards is to generate discussion amongst your peers and provide self-learning opportunities. Every class, a topic or question will be posted. Most will be related to a profession, but others may only be health care related. To improve discussion, students will be separated into groups. These groups will be where you will have an active on-line discussion (in other words, a group of 5 versus 200). The post topic will be open until the following Sunday at 8 pm , at which time it will be closed to any additional posting. The intention is to have an online discussion about the topic so I am hopeful that you will respond to your classmates posts. It is expected that everyone will have AT LEAST 2 posts per topic AND read 5 posts. At four times through the semester, participation will be calculated via posting statistics and assigned a grade. The four grades will make up your final grade for message board participation.

The message boards will not be heavily monitored, but I will browse and comment on posts. It is expected that posts are 1. respectful of others and 2. genuine in their content. In other words, a three word post like "Doctors are cool" is not genuine content. Any posts failing to meet this criteria will be deleted.

Team Presentation

The basis of any health profession is scientific peer-reviewed research. Students will have the opportunity to understand how this is accomplished as well as develop critical reviewing skills through the team presentation project. Student groups will select a topic, research the topic

utilizing peer-reviewed articles, discuss/debate merits as a group and formulate a topic statement. Student groups will collaborate to produce a 10 minute presentation to share their results to the class.

Group Participation

Utilizing the CATME team evaluation tool. Students will be assigned groups based upon submitted criteria to optimize team experience. The CATME tool will also be used to team evaluation feedback from all members of the team. The application is very robust in capturing actual team member performance in meeting objectives. Results from this will feed into your group participation grade.

Topic Brief

Similar to the group presentation, students will collaborate with their group to produce a topic brief on three of the unique characteristics of the US Healthcare System. As the name implies, the paper is not intended to be a formal written document, but rather a one to two page "brief" to inform readers. The intention is to stimulate self study and group collaboration as you compile pertinent information on these critical topics.
