PURPOSE AND OUTCOME

Course Overview

Application of accounting and financial management theory and principles to the health care industry, emphasis on provider organizations.

Relation to Program Outcomes

This course provides students with opportunities to apply the financial and accounting concepts they learned in HSA 5174 Fundamentals of Health Care Finance to real world cases to better prepare them for the multitude of tasks, challenges, and problems that arise in practice.

Course Objectives and/or Goals

Upon successful completion of the course, students will be able to:

- 1.0 Articulate a better understanding of the healthcare environment
- 2.0- Assess cost behavior and allocate costs
- 3.0– Analyze and allocate profits
- 4.0- Undertake pricing, planning, and budgeting
- 5.0 Articulate financial management concepts
- 6.0 Evaluate capital acquisition
- 7.0- Estimate costs and allocate capital and capital structure
- 8.0 Conduct financial condition analysis and forecasting
- 9.0- Manage current assets
- 10.0- Perform a business valuation

Instructional Methods

In the first three weeks of the course, we will review and reinforce the important concepts introduced in HSA 5174. Then students will be randomly assigned to four groups of 5-6 students. Each week, two cases focusing on a course objective will be provided with two teams assigned to evaluate each case. Each team will receive 35 minutes, with 20-25 minutes spent presenting their case evaluation and a 10-15 minute Q&A session fielding questions from their classmates and professor.
